In exercises of the powers conferred by Sub-section (1) of section 15 of the Minor and Minerals (Regulation and Development) Act, 1957 (67 of 1957) the Administrator, Union Territory, Chandigarh, is pleased to make the rules further to amend the Punjab Minor Mineral concession Rules, 1964, namely :-

1. These rules may be called the Punjab Minor Mineral, concession (Chandigarh Amendment) Rules, 1998.
2. They shall come into force on their publication in the Chandigarh Administration Gazette.
3. In the Punjab Mines Mineral Concession Rules (herein office called the said rules):-
 - i) In rule 30 of the said rules for sub-rule(1) the following shall be substituted, namely:-
 "Contract shall be auctioned for a period of one year unless the period is specifically stated. The successful bidder will be informed of the auction in his favour"
 - ii) In sub-rule(2), for clause(IV), the following shall be substituted, namely :-
 "No bid shall be regarded as accepted, unless confirmed by the Chandigarh Administration on completion of auction the result will be announced and provisionally accepted bidder shall immediately deposit 25 % of the bid amount. The balance amount of bid shall have to be deposited within 15 days from the acceptance of the bid"
4. In the said rules in Rule 32 for the words in other cases the balance amount shall be deposited in equal quarterly installments of the annual amount in advance on due dates, prescribed in the agreement" the following shall be substituted, namely :-
 "In other cases, the entire balance contract money shall be deposited by the contractor with the Director Mines and Mineral, Union Territory, Chandigarh, or Mining Officer concerned at the time of signing the agreement.
5. In the said rules, in 'Form' (Rule 33)(i) for para 2 the following shall be substituted namely:-
 "More of payment of contract money – In the case of the contract, where the annual contract amount exceeds Rs.1000/-, the contractor/contractors shall deposit 25% of the bid amount on the date of auction. The balance amount shall be deposited within 15 days from the acceptance of the bid."
 ii) For para '3' in the said form the following shall be substituted, namely:-
 "No quarrying operations or workings shall be carried on or permitted to be carried on by the contractor/contractors in or under the said lands or to any point within a distance of 60 meters from the National highway or 60 meters from any bridge and 5 meters from each side of the stream back and 5 meters from soil Conservation structures Breach of this shall make the contractor/contractors liable for damages/cancellation of lease.
