Whereas, the appropriate Government intends to construct Govt. High School and Community Center (Tubewell) connectivity approved in the Union Territory of Chandigarh, by acquiring land for the said public purpose.

And whereas, in view of provisions of Section 4(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013 and Rule 3(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement (Social Impact Assessment and Consent) Rules, 2014, the Social Impact Assessment is required to be carried out in consultation with the concerned Gram Panchayat and Municipal Corporation in the affected areas. The proposed acquisition for the said public purpose would entail about 3.72 acres of land. This land shall be acquired from Khasra No. 11/21/2, 22/2, 23/1/2, 20/1, 2, 3/1, 8/2 and 9, measuring area 29 Kanal 15 Marlas (approx. 3.72 acre) thus affected area shall be Village Kishangarh, Manimajra, H.B. No. 375, Tehsil & District, U.T., Chandigarh. The Social Impact Assessment shall be conducted in respect of the matters as specified in Section 4 of the Act of 2013.

It is hereby notified that the proposed acquisition of land pertains to the purpose specified under the provisions of the said Act of 2013 and the entire Social Impact Assessment shall be carried out in consultation with Panchayat and land owners.

The Social Impact Assessment (SIA) shall commence from the date of issuance of this Notification, which shall be completed within six months. The important output of the SIA shall include Social Impact Assessment report and Social Impact Management Plan shall be made available in terms of Section 6



The Social Impact Assessment shall be carried out by the Panjab University, Chandigarh which has been notified as Social Impact Assessment (SIA) Unit as per the provisions of Rule 4(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement (Social Impact Assessment and Consent) Rules, 2014. 
