No.11/8/137-UTFI(3)/2018/ 8906 Whereas the Chandigarh Administration vide its Notification No.11/8/137-UTFI(3)/2018/21355 dated 20.11.2018 established the Real Estate Regulatory Authority and Real Estate Appellate Tribunal as notified by the Government of NCT of Delhi for the Union Territory of Chandigarh to exercise and perform the functions assigned to it. The said Authority should be known as the Real Estate Regulatory Authority and Real Estate Appellate Tribunal for Union Territory Delhi and Union Territory Chandigarh.

3. Shri Ramesh Chandra Son of Shri Badri Prasad - Member


