PUBLIC NOTICE FOR INFORMATION TO ALL CONCERNED

In continuation of public notice qua the selection and appointment of one Steno-Typist, exclusively from SC category, published in English newspaper "Hindustan Times" dated 17/6/2014, it is informed total 36 candidates including the candidates sponsored by Regional Employment Officer, Chandigarh, were called for stenography test on 2/8/2014 in Govt. Polytechnic for Women, Sector 10, Chandigarh. Out of 36 candidates, only 14 candidates appeared in the stenography test.

The stenography test was of 90 marks. The performance in stenography test assessed on the basis of mistake committed in the test. Except, below mentioned three candidates, remaining all the candidates committed unlimited mistakes and awarded no marks.
