The Chandigarh Administration has notified a Policy for Solid Waste Management in the Union Territory of Chandigarh called as "**Chandigarh Solid Waste Management Policy**" issued vide no. FII(9)-2018/13581 dated 04.09.2018 in accordance with the provisions under rule-11 (1) of Solid Waste Management Rules, 2016, notified by Ministry of Environment Forest and Climate Change, New Delhi.

Whereas a Committee was constituted by the Chandigarh Administration vide Notification No. FII(9)-2018/13655 dated 05.09.2018, to receive suggestions from the General Public and other stakeholders within a period of 7 days and to give its recommendation for amendments in the notified policy. As such the copy of Notification No. FII(9)-2018/13581 dated 04.09.2018 was placed in the public domain for inviting suggestions/comments.

Therefore on the recommendations of the Committee constituted for scrutinizing the objections/suggestions so invited from the general public and stakeholders, the Administrator, Union Territory, Chandigarh is pleased to amend the "Chandigarh Solid Waste Management Policy" by changing/substituting the timeline stipulated for implementation of Solid Waste Management Rules in Para No. 5.18 of the Policy *ibid* in the manner prescribed hereunder:-

1. In Sr. No. 4, the timeline "31.12.2019" is substituted as "31.12.2018".
2. In Sr. No. 5, the timeline "31.12.2019" is substituted as "31.12.2018".
3. In Sr. No. 6, the timeline "31.03.2019" is substituted as "31.12.2018".
4. In Sr. No. 11, the timeline "31.12.2020" is substituted as "31.12.2018".

The column No. 3 regarding "Time limit from the date of Notification of Rule" in the Policy stands omitted.
