No.F-II(8)/2020/6633 The Administrator of Union Territory of Chandigarh in exercise of the powers conferred under section 90 (2)(b) & 90(3) of the Punjab Municipal Corporation Act, 1976 as extended to Union Territory, Chandigarh by the Punjab Municipal Corporation Law (extension to Chandigarh) Act, 1994 (Act No 45 of 1994), is pleased to approve that the Municipal Corporation, Chandigarh shall levy the **COVID Cess @ 5%** on Minimum Retail Sale Price, on all categories of liquor sold through wholesale licensees, for taking necessary emergent measures, for preventing and checking the spread of COVID-19/dangerous diseases, to fulfill the obligatory function prescribed under section 44 (h) of the Act *ibid*.

The above said COVID Cess shall be collected and remitted to the Municipal Corporation, Chandigarh by the Excise and Taxation Department, UT, Chandigarh in the dedicated account of special fund namely COVID Cess Fund of Municipal Corporation Chandigarh. It is added that the above mentioned Covid Cess should be collected, kept apart in a separate account and not spent till clarification from MHA is received.

These orders will come into force with immediate effect and remains effective upto 31st Dec, 2020 or till further orders whichever is earlier.
