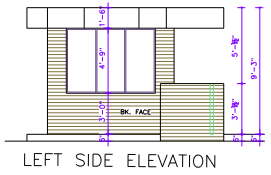
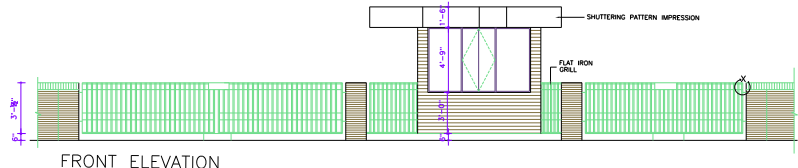


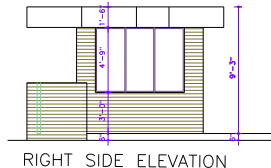
REAR ELEVATION



LEFT SIDE ELEVATION

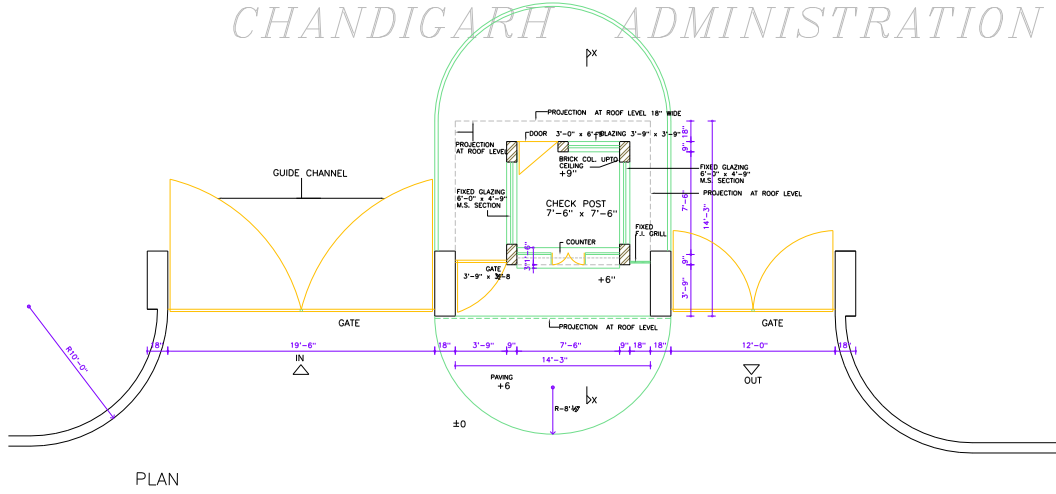


FRONT ELEVATION

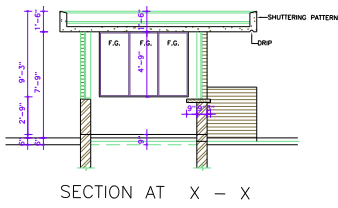

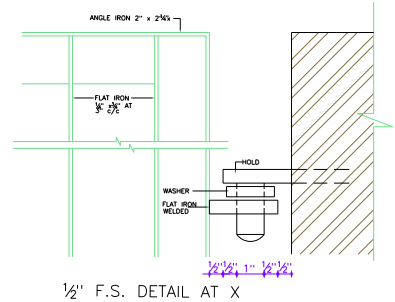
