- DRAWING No. 18.10.20 (JOB No. 21) IS TO BE READ TOGETHER AND FORM PART OF THE ARCHITECTURAL CONTROL ON THE SITE. THE SITE NO. 21 IS SITUATED IN THE LAY OUT PLAN OF SHOOTING CENTRE OF SECTOR 24/D DRG. No. 37. JOB No. 20.
- FLOOR LEVELS SHALL BE KEPT IN ACCORDANCE WITH THAT INDICATED ON THE LAY OUT PLAN OF SHOOTING CENTRE DRG. No. 37, JOB No. 20.
- FRONT VERANDAH ON THE GROUND FLOOR SHALL BE ALUMINUM FRAMED AND NO ENCROACHMENT OF VERANDAH SHALL BE ALLOWED. THE FINISHING OF RAISING SHALL BE IN STRICT ACCORDANCE WITH THE DESIGN AND SPECIFICATION SHOWN ON THE DRAWING AND EXECUTED AND MAINTAINED BY THE OWNER TO THE ENTIRE SATISFACTION OF THE CHIEF ARCHITECT.
- EXPANDED BRICK WORK SHALL MEAN FAIR FACED BRICK WORK WITHOUT ANY PAINT (COLOURWASH) OR POINTING.
- PLASTERED SURFACES WHEREVER SHOWN ON THE DRAWINGS SHALL BE WHITE WASHED UNLESS OTHERWISE SPECIFIED.
- INTERNAL CHANGES MAY BE ALLOWED SUBJECT TO THE PRIOR APPROVAL OF THE CHIEF ARCHITECT.
- NO ALTERATIONS IN THE EXTERNAL FACEDS SHALL BE ALLOWED.
- THE EXTERNAL DOORS, WINDOWS, SHUTTERS AND JOINERY WORK IN STEEL OR IN WOOD AS SPECIFIED SHALL BE PAINTED IN GREY COLOUR OF THE EXTERIOR.
- NO APPROACHWAYS SHALL BE ALLOWED ON PLACES OTHER THAN AT ENTRANCES.
- COURT YARDS SHALL REMAIN OPEN TO SKY AS SHOWN ON THE DRAWINGS.
- NO RAIN WATER, SOIL, VENTILATING OR ANY OTHER PIPE SHALL BE DISCHARGED ON THE EXTERNAL FACE OF ANY WALL.
- THE MEANS OF TAKING ELECTRICAL, TELEPHONE OR ANY OTHER CONNECTIONS FROM THE PUBLIC SUPPLY LINES SHALL BE SHOWN ON THE BUILDING PLANS AND SHALL BE SUBJECT TO THE APPROVAL OF THE CHIEF ARCHITECT.
- ELECTRICAL INSTALLATIONS AS FAR AS LIGHT FITTINGS ARE CONCERNED SHALL BE SHOWN ON THE PLANS.
- NO WATER STORAGE OR ANY OTHER TANK SHALL BE PROVIDED BY OR ON THE HEIGHT OF THE PARTY WALL OR PARTY WALL SO AS TO BE VISIBLE TO THE PUBLIC. EACH CHIMNEY STACK SHALL BE SET BACK AT LEAST 3'0" FEET AWAY FROM ANY EXTERNAL OR PARTY WALL OF ANY BUILDING AND THE EXTERIOR BRICK FACED PART SHALL NOT PROJECT ABOVE THE ROOF LEVEL.
- ONLY QUALIFIED ARCHITECTS ARE ALLOWED TO SUBMIT PLANS, SUPERVISE CONSTRUCTION AND ISSUE COMPLETION CERTIFICATES FOR THESE BUILDINGS.

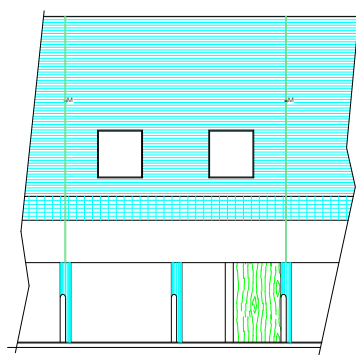

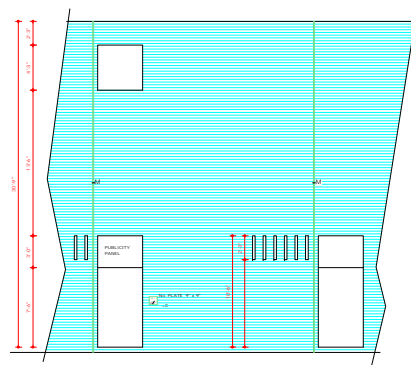

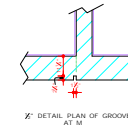

FRONT ELEVATION



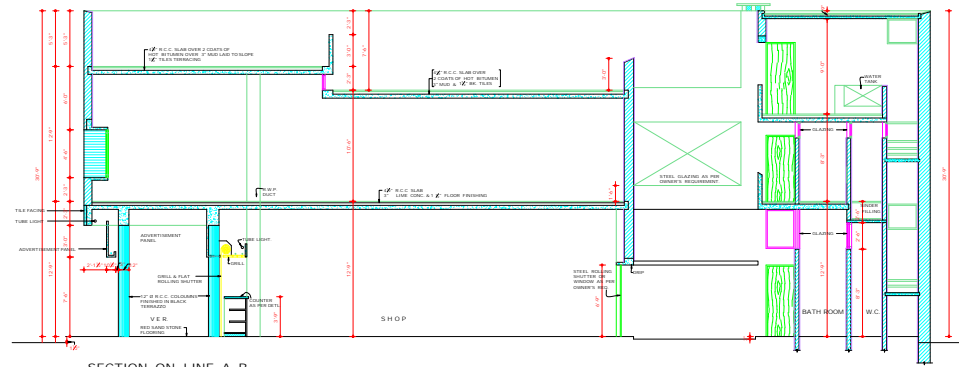
REAR ELEVATION
