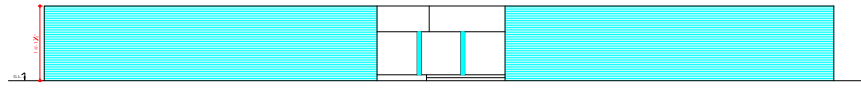
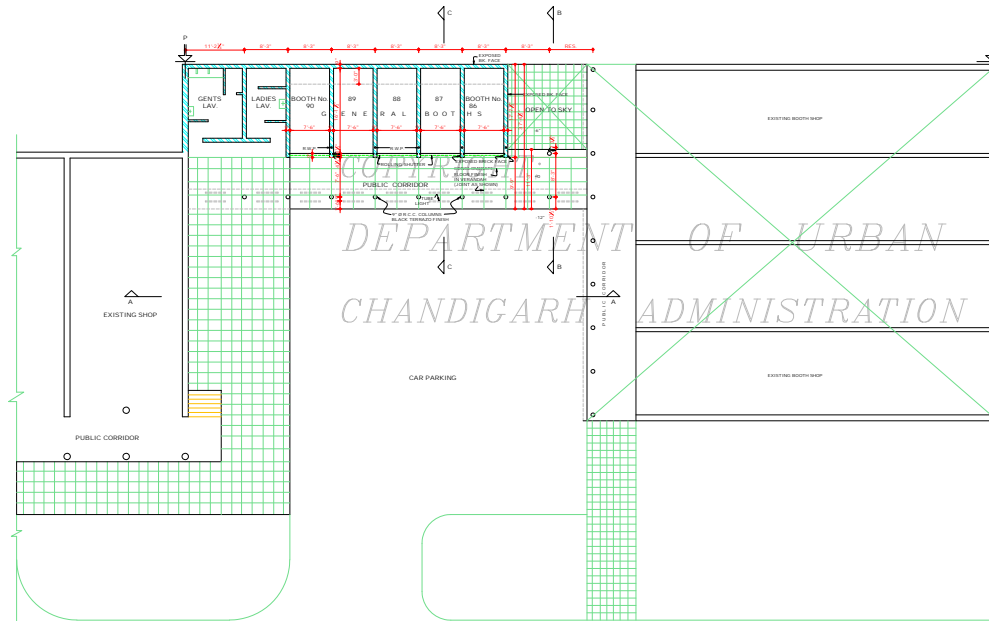


SECTIONAL ELEVATION AT A-A

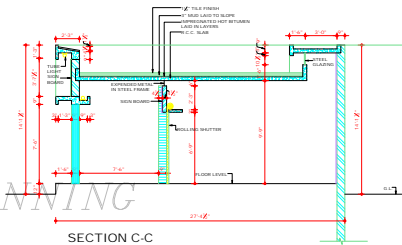


ELEVATION AT P-Q

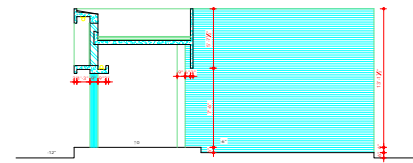


PLAN

V4 - ROAD



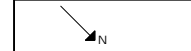
