ORDER

No.13180-HIII(5)/2021/7420
Dated 24/05/2021

Further to Order No.13180-HIII(5)/2021/6593, dated 04/05/2021, wherein several restrictions were imposed for effective control of covid-19, the following relaxations are hereby granted as per decision taken in the War Room meeting dated 24/05/2021 :-

1. All shops are allowed to remain open from 09:00 AM to 03:00 PM, subject to strict observance of covid protocol.
2. Restaurants including hotels, cafe, coffee shops, eating places are allowed to function only for home delivery. No seating arrangements will be allowed inside their premises. Home delivery can be done upto 10:00 PM and take-aways are allowed upto 05:00 PM.
3. Sampark Centres will remain open from 09:00 AM to 05:00 PM. However, strict covid protocol will be followed. Necessary facility for sanitation should be provided in the premises.
4. Sport complexes will remain closed. However, special permission can be given by Secretary Sports to athletes preparing for Olympics, National Games etc.
5. All other directions issued vide Order No. 13180-HIII(5)/2021/6593, dated 04/05/2021 & Order No. 13180-HIII(5)/2021/6952, dated 10/05/2021 (copies enclosed) will continue till 05:00 AM on 01/06/2021.


Any breach of this order shall invite action under Section 51 to 60 of the Disaster Management Act, 2005 and Section 188 of the Indian Penal Code along with other applicable laws.







ORDER

No.13180-HIII(5)/2021/6952
Dated 10/05/2021

Whereas, vide order No. 13180-HIII(5)/2021/6593, dated 04/05/2021 (copy enclosed), night curfew and weekend curfew from 04/05/2021 (05:00 PM) to 11/05/2021 (till 05:00 am) was declared in the UT, Chandigarh alongwith guidelines to be implemented during the period.

Whereas, situation of COVID-19 in U.T., Chandigarh has been reviewed in War Room meeting held on 10/05/2021 and to contain the spread of Covid pandemic in the UT, in exercise of the powers conferred under Section 22 of the Disaster Management Act, 2005, in my capacity as Chairperson, State Executive Committee, State Disaster Management Authority hereby extend the restrictions imposed vide the above referred order dated 04/05/2021 for another one week i.e. from 11/05/2021 (05:00 AM) to 18/05/2021 (till 05:00 AM) in the UT, Chandigarh. The earlier guidelines dated 04/05/2021 will continue to be implemented during the aforesaid period.

Further, the following amendments are hereby made in the guidelines dated 04/05/2021 referred to above :-

Amendments of Sr. Nos.2(n) & (o)

- n) The gathering for the occasions like marriages will be restricted to 20 and for cremation/funeral, it will be restricted to 10 persons.
- o) Crowded places like Sukhna Lake, Museums, Libraries, Rock Garden etc. will remain closed. The parks, however, will remain open from 6 AM till 9 AM.



Any breach of this order shall invite action under section 51 to 60 of the Disaster Management Act, 2005 and section 188 of the Indian Penal Code along with other applicable laws.

This order shall come into force with effect from 5 AM on 11/05/2021 and shall remain in force till 5 AM on 18/05/2021.







ORDER

No.13180-HIII(5)/2021/6593
Dated 04/05/2021

Whereas, vide order no. 40-3/2020-DM-I(A), dated 29/04/2021, the Union Home Secretary, Ministry of Home Affairs, Govt. of India had issued an order under Section 10(2)(1) of the Disaster Management Act 2005, stipulating the guidelines for effective control of COVID-19 in the country up to 31/05/2021.

Whereas, situation of COVID-19 in U.T., Chandigarh has been reviewed in War Room meeting held on 03/05/2021 and it has been observed that there has been a sharp increase in COVID-19 cases during last few days.

Now, therefore, the undersigned in exercise of the powers conferred under Section 22 of the Disaster Management Act, 2005, in my capacity as Chairperson, State Executive Committee, State Disaster Management Authority hereby issues the following directions :-

1. Night curfew will continue from 6 PM to 5 AM every day. Further, total weekend curfew on Saturday and Sunday will also continue. Detailed order in regard to the weekend curfew order shall be issued by the District Magistrate.
2. There will be day time restrictions w.e.f. 5 PM on 04/05/2021 (Tuesday), till 5 AM on 11/05/2021 (Tuesday). During these 07 days period, the following restrictions will be imposed :-
 - a) All shops selling non-essential items will remain closed.
 - b) The shops selling essential items like milk, bread, vegetables, fruits, dairy products, eggs, meat, groceries, bakeries, opticians, mobile repair, etc. will be allowed to remain open.



- c) Restaurants including hotels, Cafe, Coffee Shops, Eating Places will be allowed to function only home delivery. No seating arrangements will be allowed inside their premises. Home delivery can be done upto 9 PM and take-aways will be allowed till 5 PM.
- d) All government offices and banks will work with 50% capacity. However, this will exclude all departments/organizations, who are attending covid related work. Further, as per the guidelines of Govt. of India, all officers of the level of the Deputy Secretary, equivalent and above shall attend office on regular basis. Head of the Departments shall prepare roster for the attendance of the staff concerned.
- e) Visitors will be allowed to meet officials only with prior appointments. They may be required to produce vaccination certificates or negative RT-PCR reports.
- f) As far as possible, all private offices will ensure that their staff shall work from home.
- g) Public Transport will run with 50% capacity.
- h) The ban on Cinema Halls, Gyms, Spa, Bar, Swimming Pool, Coaching Centres will continue.
- i) Sports Complexes will remain closed. Special permission can be given by Secretary (Sports) to athletes preparing for Olympics etc.
- j) There shall be a complete ban on all social, cultural, sports and political gatherings.
- k) Recruitment exams will be postponed except those like UPSC etc., which are specifically permitted by Chandigarh Administration.



- l) While there will be no restriction on inter-state movement, yet those entering Chandigarh without negative covid reports or vaccine certificates will be subject to random testing.
- m) All Hospitals, Nursing Homes and Health related facilities like testing laboratories etc. will be allowed to function normally.
- n) The gathering for the occasions like marriages will be restricted to 50 and for cremation/funeral, it will be restricted to 20 persons.
- o) Crowded places like Sukhna Lake, Museums, Libraries, Rock Garden etc. will remain closed. The parks, however, will remain open from 5 AM till 9 AM.
- p) School, Colleges, Coaching Centres will remain closed. However, teaching staff will be required to come as per detailed instructions to be issued by the Education Department.
- q) While movement of vehicles has been allowed during day time, the residents are requested to stay at home and avoid unnecessary travel.
- r) The manufacturing units/industry shall be allowed to remain open. The movement of employees/labour of manufacturing unit/industry and vehicles carrying them shall be allowed. However, concerned unit/industry shall issue them requisite permission/identity cards for the purpose and details of the same shall be shared with the Director Industries, Chandigarh.
- s) Street vendors dealing with essential items and mobile street vendors will be allowed upto 5 PM.
- t) All government offices in the city will close at 5 PM.




