Reservation of Beds in Private Hospitals/Nursing Homes for COVID-19 patients.

In supersession of earlier order No. FW/CEA/2021/153 dated 30.04.2021 and in exercise of the powers conferred under "The Chandigarh Epidemic Disease, COVID-19 regulations, 2021 dated 25.05.2021 notified under Epidemic Disease act 1897", the order No. FW/CEA/2021/153 dated 30.04.2021 regarding the 50% reservation of beds in Private Hospitals/ Nursing Homes for COVID-19 Patients hereby stands cancelled with immediate effect.

Further those Hospitals/Nursing Homes admitting COVID-19 patients will be required to follow all the COVID protocols and instructions of MoH&FW in the management and treatment of COVID-19 patients. Also the status and treatment charges for COVID-19 patients availing treatment at Private Hospitals/Nursing Homes will be in accordance to the order vide Memo No. PA/DHS/2021/580 dated 04.06.2021.


