Now that there has been further reduction in number of cases of covid-19 in the city, therefore, vide order No.13180-HIII(5)/2021/7901, dated 08/06/2021 various relaxations were allowed.

However, after detailed discussions in the War Room meeting held on 15/06/2021, the following additional relaxations are provided in modification of order dated 08/06/2021:-

- 1. All shops will remain open from 10:00 AM to 07:00 PM. The shop owners will ensure that covid protocol is duly followed.
- 2. All restaurants/bars can remain open with 50% capacity from 10:00 AM to 10:00 PM.
- 3. The night curfew in the city will be from 10:30 PM to 05:00 AM.

Any breach of this order shall invite action under Section 51 to 60 of the Disaster Management Act, 2005 and Section 188 of the Indian Penal Code along with other applicable laws.

This order shall come into force with effect from 6 AM on 16/06/2021 and will be applicable until further orders.
