

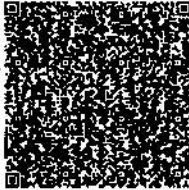

JUDGMENT

1. The above named accused persons have been sent up to face trial for the commission of offences punishable under Sections 323 and 325 read with Section 34 of IPC by the SHO of Police Station Pehowa.

2- In brief, the prosecution story are that on 16.11.2017 a telephonic message was received that Pargat Singh s/o Gurmel Singh r/o House no. 2290, BSNL colony, Sector 50, Chandigarh was admitted in GMSH 16, Chandigarh.

On the basis of said information SI Mewa Singh alongwith other police officials reached at GMSH 16, Chandigarh where doctor declared injured fit for statement. Injured Pargat Singh recorded his statement that he is residing at the abovesaid address and was a student of French Deptt. In Punjab University, Chandigarh. On 16.11.2017 he came to attend the fest Agaaz-2017 in University, 15/11/17 around at 10:00 PM when he was going to botany parking via student centre four people named as Gurjot Sandhu, Sachin Galav, Pardeep Gurjar and Yadvinder Singh came towards him with sharp weapon (Sword) and hit on his forehead and leg. They threatened him and ran away from the place. Hence, the complainant prayed to take necessary action against the accused.

3- On this complaint, endorsement was made and FIR was registered. Investigation began. Rough site plan of the place of occurrence was prepared. Accused persons were apprehended. Evidence was collected. Statements of witnesses were recorded and after completion of necessary investigation, challan was prepared and sent to the Court for commencement of the trial against the accused.

4- Copies of challan and other documents were supplied to the accused free of costs as envisaged under section 207 Cr.P.C.

5- Accused persons were charge sheeted for the commission of offence punishable under sections 324 read with Section 34 of IPC. The contents of charge were read over and explained to them in simple Hindi, to which the accused persons pleaded not guilty and claimed trial.

6- Prosecution, to prove its case, has examined so many witnesses

namely H.C. Jai Bhagwan as PW1, SI Mewa Singh as PW2, Dr. Gurdeep Kaur Kang, EMO, GMSH-16 as PW3, Pargat Singh as PW4, C. Pardeep Kumar as PW5, C. Neeraj as PW6, C. Sonu as PW7, HC Ram Kumar as PW8. Thereafter, evidence of prosecution was closed by learned APP for the State on 12.03.2019.

7- Statements of accused under section 313 Cr.P.C. was recorded in question answer form on 26.03.2019, whereby the accused persons pleaded his innocence and sought date for adducing defence evidence.

8- In defence evidence accused examined Ranbir Singh, Clerk, Botany, Punjab University as DW-1, Raj Kumar, Assistance Security Officer, Punjab University, Chandigarh as DW-2, Jagmohan Singh as DW-3 and closed the defence evidence later.

9. Ld. APP for the State argued that he has fully proved the case of the prosecution by leading oral as well as documentary evidence. On the other hand Id. Counsel for the accused argued that the accused has been falsely implicating in the present case and a false case has been registered against him.

10- I have heard learned Public Prosecutor for State and learned defence counsel for accused and also gone through the case file very carefully with their kind assistance.

POINTS FOR DETERMINATION:-

Whether on 15.11.2017 at about 10:00 PM in the area near Botany Parking, Punjab University, Chandigarh, the above said accused alongwith your co-accused in furtherance of pure common

intention attacked the complainant Pragat Singh and caused hurt by using sharp weapon i.e. Sword ?

11- In the present case, the onus is on the prosecution to prove that all the accused persons has jointly caused injuries to the complainant by using sharp as weapon. In order to prove the above said allegation, the onus is on the prosecution to led evidence regarding causing of injuries and infliction of the same by the accused persons. For that it is also required to be proved that the story is believable one. In the present case FIR was registered on the basis of complaint moved by Pargat Singh. Prosecution examine Pargat Singh as PW-4 who proved his original complaint as Ex. P-1 on the case file. The complaint Ex. P-1 is the very basis of case. Perusal of the original complaint shows that there is no specific allegation against all the accused persons. The complainant simply stated in her complaint that all the accused persons came towards him and hit him with sharp as weapon (sword) on forehead and leg. When Pargat Singh was examined as PW-4 then also he simply stated that all the accused persons caused injuries to him with a blow of some sharp as weapon. Firstly, there is a major contradiction as regard to the nature of weapon used by the accused. As per the original complaint, the alleged injury was caused with the sword. But when complainant was examined before the court then he simply stated that injury was caused with sharp as weapon. Therefore, there is a major contradiction as regard to nature of weapon. Moreover, there is no specific attribution to any of the four accused. The complainant simply alleged that the accused persons gave a blow of sharp weapon. He nowhere explain about attribution of any specific injury by

any of the accused. In order to make his story believable it is for the complainant to explain the manner in which the alleged injury was caused and accused who specifically caused that injury. Therefore, it is for the complainant to explain about the name of the person who was having the sharp edged weapon and who had caused injuries to him. But in that regard not only the complaint but his deposition is completely silent. Therefore, the allegation are appears to be general and fictitious in nature. Unless there is a specific attribution of injury to the accused person and unless role of all the accused persons are explained till then it cannot be said that the complainant has received injuries in the hand of accused persons. Therefore, the story of the complainant is also not believable and certain material linking pin are missing in his deposition. Which means his deposition is not credible and is full of lacuna.

12. Moreover, there is a delay of one day in filing the present complaint. As per allegation, the complainant had received injuries in the hand of accused on 15.11.2017 at about 10:00 PM. There is no allegation that the complainant was unconscious and were not able to move the complaint. But perusal of case file shows that the complaint was moved on 16.11.2017 at about 5:15 PM. Therefore, there is a considerable delay between the alleged incident and moving of the first complaint. That means complainant is having time to frame a story of his convenience and to fabricate facts for falsely implicating any number of person as accused. Therefore, chances of concoction of story could not be ruled out. The delay in lodging FIR also remain unexplained and it is a major lacuna to disbelieve the prosecution version.

13. Moreover, there is nothing on the case file which could show the motive behind causing of the alleged injury. Rather it has come in the deposition of PW-4 that the complainant and accused persons are member of NSUI. Once there is no motive then the story of the prosecution has become more doubtful. Unless there is motive till then it cannot be said as to why accused persons would have caused injuries to the complainant. Therefore, absence of motive also goes against the prosecution and surely benefit the accused persons.

14. Therefore, the accused persons are acquitted of the charges framed against them by extending benefit of doubt. Their bail/surety bonds also stand discharged. Case property if any, be destroyed as per rules after expiry of period of appeal or revision. File be consigned to records after due compliance.

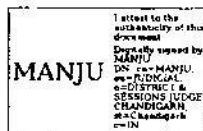

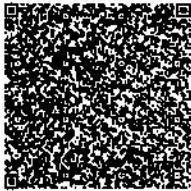
