



NOTES:-

1. Although, the Gradation/Seniority List as on 01.01.2021 has already been finalized vide this Department's letter No. 34/129/26-IH(11)-2022/6628 dated 28.04.2022. However, the same is required to be reviewed as it has come to the notice that some of the Clerks, who were appointed by other Departments of UT Chandigarh on either Direct Recruitment; on Court Directions; Promoted and on Compassionate Ground at their own level after issuance of notification dated 29.05.2015 and were left out inadvertently while finalizing the same vide above letter. Thus the review is being made in consultation with the Department of Personnel (Personnel-I Branch), Chandigarh Administration and in pursuance of the Clause No. (E) under heading "**Powers of review and revisions**" of Notification dated 24.01.1992 issued by the Chandigarh Administration regarding Delegation of Powers by incorporating their names at appropriate place.
2. As per Government of India, Ministry of Personnel, Public Grievances & Pension, New Delhi O.M dated 04.03.2014 duly adopted by the Department of Personnel, Chandigarh Administration vide letter dated 26.10.2020 regarding Inter se seniority of direct recruits and promotes, the manner of determination of inter-se-seniority of direct recruits and promotes, would be as under:
 - (e) Initiation of recruitment process against a vacancy year would be the date of sending of requisition for filling up of vacancies to the recruiting agency in the case of direct recruits; in the case of promotes the date on which a proposal, complete in all respects, is sent to UPSC/Chairman – DPC for convening of DPC to fill up the vacancies through promotion would be the relevant date.
 - (i) The process for filling up the posts on direct recruitment was initiated on 27.09.2010. However she was offered appointment as a Clerk on 12.08.2015 by Police Department, UT, Chandigarh.
 - (ii) The proposal for filling up the posts for Promotion to the post of Clerk was sent to the DPC on 22.05.2015 and he was promoted to the post of Clerk w.e.f 01.06.2015 by Police Department, UT, Chandigarh.

- (iii) The proposal for filling up the posts on Promotion was sent to the DPC on 17.10.2016 and he was promoted to the post of Clerk w.e.f 22.11.2016 by Estate Office, UT, Chandigarh.
3. The clause No. 4.8 under Heading-**“Seniority of persons Compassionates”** of OM dated 16.09.2022 issued by Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, New Delhi provides as under:-
- (a) The inter-se seniority of persons appointed on compassionate grounds may be fixed with reference to their date of appointment. Their interpolation with the direct recruits/promotees may also be made with reference to their date of appointment without disturbing the inter-se seniority of direct recruits/promotees.
- (b) Date of joining by a person appointed on compassionate grounds shall be treated as the date of his/her regular appointment.
- The person appointed on compassionate ground in a particular year would be placed at the bottom of all the candidates recruited/appointed through direct recruitment, promotion etc. in that year, irrespective of the date of joining of the candidate on compassionate grounds.**
4. The Gradation/Seniority List as on 01.01.2021 has already been finalized vide this Department’s letter No. 34/129/26-IH(11)-2022/6628 dated 28.04.2022.
5. **Besides, Note 4 above, as per advice of Department of Personnel (Personnel-I Branch), Chandigarh Administration, the recruitment for the 253 post against Advertisement dated 06.10.2015 of Clerks made during the years 2016 to 2018 is a single selection. As such, the officials appointed on Compassionate Ground/Direct Recruitment/Promotion etc. have been placed at the bottom of all the direct recruits whose recruitment process initiated in the year 2016 and completed in the year 2018 accordingly.**
6. **Appointed as per directions of Hon’ble Punjab & Haryana High Court by O/o State Transport Authority, UT, Chandigarh.**
7. As per clause No. 2.1.1 under Heading **“Seniority of Direct Recruits”** of the OM dated 16.09.2022 issued by Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, New Delhi, ***the seniority of all direct recruits is determined by the order of merit in which they are selected for such appointment.***
8. As per clause No. 7 under heading **“Selection Procedure”** of the Recruitment Notice dated 21.10.2019, ***in case two or more candidates secure equal merit then the candidate older in age will rank higher in merit list at the time of final selection.***
9. The clause No. 2.4.6 (c) of OM dated 16.09.2022 issued by Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, New Delhi, which provides as under:-
- “For recruitments initiated on or after 19.11.2019 as well as for future recruitments, in addition to cases where the recruitment process has been initiated by the administrative Department/ Cadre Authority before 19.11.2019, but where all appointments, subsequent to the initiation of recruitment process, could be made only on or after 19.11.2019 i.e. date of order of Apex Court, the inter se seniority of direct recruits and promotes shall be determined in the following manner -**
- (c) Where **in case of promotees** or direct recruits, the year of appointment is the next year or any year subsequent to the recruitment year, **the seniority of such promotees** and direct recruits **would be determined with reference to the year of their actual joining/ appointment to the post.** Since they were not able to join in the said recruitment year in which the vacancy arose. **Thus, they would get seniority of the year in which they actually join i.e. year in which formal appointment order is issued or they are borne in the service/ cadre and that they shall not get seniority of any earlier year (viz. year of Vacancy/panel or year in which recruitment process is initiated).**

Further, as per “NOTE” mentioned in the notification dated 14.11.2019 i.e., Chandigarh Administration Group-C (Clerk and Steno-Typist) (Common Cadre)(Second Amendment) Recruitment Rules, 2019 which provides ***that the***

seniority will be determined on basis of their seniority in the office/ department to which they belong and if they belong to different offices/ departments/cadres, the older members shall be senior to the younger.

As such after obtaining the Gradation List/Seniority Orders from the Transport Department vide letter No. 5997/EAC/HO/ CTU/ 2024 dated 19.03.2024 (**as the official mentioned at Sr. No. 497 to 505 belongs to one Department i.e., Transport**).

The official mentioned at Sr. No. **490 to 505** belongs to ***different offices/ departments/cadres***, as such their seniority is determined on the basis clarification received from Department of Personnel, Chandigarh Administration vide UO No. RR(185)-IH(9)-2024/3786 dated 19.03.2024, according to which seniority of these officials is determined on the basis of length of continuous service on a post in service.

10. Although, the officials secured more marks in comparison in the merit list to the officials mentioned above in the Tentative Seniority List, but case(s) has/have been considered in terms of clause No. 2.4.6 (c) of OM dated 16.09.2022 issued by Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training, New Delhi, which provides as under:-

“For recruitments initiated on or after 19.11.2019 as well as for future recruitments, **in addition to cases where the recruitment process has been initiated by the administrative Department/ Cadre Authority before 19.11.2019, but where all appointments, subsequent to the initiation of recruitment process, could be made only on or after 19.11.2019 i.e. date of order of Apex Court, the inter se seniority of direct recruits** and promotes **shall be determined in the following manner** -

(c) Where **in case of** promotees or **direct recruits**, the year of appointment is the next year or any year subsequent to the recruitment year, **the seniority of such** promotees and **direct recruits** would be determined with reference to **the year of their actual joining/ appointment to the post**. Since they were not able to join in the said recruitment year in which the vacancy arose. **Thus, they would get seniority of the year in which they actually join i.e. year in which formal appointment order is issued or they are borne in the service/ cadre and that they shall not get seniority of any earlier year (viz. year of Vacancy/panel or year in which recruitment process is initiated).**”

The officials mentioned at Sr. No. 506 to 535; 546 to 564 and 567 have been offered appointment after issuance of promotion orders dated 17.09.2021, as such they are placed in pursuance of above instructions.

11. As per clause No. 8 under heading “**Selection Procedure**” of the Recruitment Notice dated 21.10.2019 provides that **in case two or more candidates secure equal marks and their date of birth may happen to be same then the candidate having higher percentage in educational qualification shall rank higher in the order of merit list** at the time of final selection.

The officials mentioned at **Sr. No. 558 & 559** have same merit and same date of birth. They have secured 59.95% & 47.77% of marks respectively in their Essential Qualification for the post of Clerk as mentioned in the Documents/Forms filled for the said post. Thus the official mentioned at Sr. No. 558 & 559 accordingly.

As such the official mentioned at Sr. No. 557 to 560 are placed accordingly.

12. The appointment of the official mentioned at Sr. No. 567 made in compliance of the Interim Order dated 15.11.2022 provisionally subject to the final outcome of the OA No. 1186 of 2022. As such, the seniority of the official is provisional and subject to final outcome of the OA & subsequent decision of the competent authority.
