NOTIFICATION

Chandigarh dated the 12/5/26

No. E.51517-HIII(1)-2026/4113 In exercise of powers conferred by the proviso to Article 309 of the Constitution of India read with the Government of India, Ministry of Home Affairs, Notification bearing S.O. 3267, dated 1st November, 1966, the Administrator, Union Territory, Chandigarh is pleased to amend "The Constable [Male and Female Constable (Executive)] of Group-C Chandigarh Police Department, Union Territory of Chandigarh Recruitment Rules, 2023 notified vide Notification bearing No. F/331-HIII(1)-2023/5903-5909, dated 28.04.2023, as under:-

1. **Short title and commencement:-** (i) These rules may be called the Constable [Male and Female Constable (Executive)] of Group-C, Chandigarh Police Department, Union Territory of Chandigarh (1st Amendment) Recruitment Rules, 2026.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. In the said Rules, below the Sub Rule 3.10 of "Rule 3 Definition", the following shall be added:-

3.11 Transgender person: A transgender Person means a person whose gender does not match with the gender assigned to the person at birth and includes trans-man or trans-woman (whether or not such person has undergone Sex Reassignment Surgery or hormone therapy or laser therapy or such other therapy), person with intersex variations, gender-queer and person having such socio-cultural identities as kinner, hijra, aravani and jogta as defined in the Transgender Person (Protection or Rights) Act, 2019 (Central Act 40 of 2019).

i) 'Recognition of identity of transgender person' shall be as specified under Section 4;

ii) 'Application for certificate of identity' shall be as specified under Section 5;

iii) 'Issue of certificate of identity' shall be as specified under Section 6;

iv) 'Change in gender' shall be as specified under Section 7 of 'The Transgender Persons (Protection of Rights) Act, 2019, (Act No. 40 of 2019).

3. Note mentioned below Rule 13 shall be omitted.

4. The following Note shall be added below the table in Annexure-EQ appended with these Rules:-

"As per the certificate of identity issued by the District Magistrate to a transgender person under the Transgender Persons (Protection of Rights) Act, 2019 (Central Act 40 of 2019), the criteria prescribed for male or female candidates shall apply, as the case may be, where male or female is mentioned in the certificate."

5. The following Note shall be added below the table in Annexure-PQ appended with these Rules:-

"As per the certificate of identity issued by the District Magistrate to a transgender person under the Transgender Persons (Protection of Rights) Act, 2019 (Central Act 40 of 2019), the criteria prescribed for male or female candidates shall apply, as the case may be, where male or female is mentioned in the certificate."
