PUBLIC NOTICE

Extension of period of Excise Policy for the year 2016-17

- The Chandigarh Administration has decided to extend its Excise Policy for the year 2016-17 by 06 days i.e. till 06.04.2017.
- The period of licencees i.e Wholesale and Retail sale in the form of BWH-2, D-2, L-1B, L-1C, L-1C1, L-1D, L-1DF, L-1F, L-2, L-3/L-4/L-5, L-4/L-5, L-4A/L-5A, L-3A/L-4A/L-5A, L-9, L-10A, L-10B, L-10C, L-11, L-12C, L-12D, L-13, L-14A, L-15, L-16, L-17 and L-52(Tavern) were to expire on 31.03.2017 are now given an option to extend this period till 06.04.2017 (except those L-2/L-14A, L-3/L-4/L-5, L-3A/L-4A/L-5A, L-10A, L-10B, L-10C & L-12C, who falls within the radius of 500 meters from the National/State Highway, as per the orders passed by the Hon'ble Supreme Court of India dated 15.12.2016).
- All the licencees Wholesale and Retail sale will be required to submit their consent for extension on or before **31.03.2017** by **05:00 PM**.
- They will further be required to deposit the license fee for 6 days in the form of Demand Draft/Treasury Receipt along with their consent form.
- The license fee will be calculated on pro rata (proportionate) basis by calculating it on annual fee charged for the Policy year 2016-17.
