TENDER NOTICE FOR THE WHOLESALE SUPPLY OF COUNTRY LIQUOR FOR THE YEAR 2017-18 (COMMENCING FROM 07th APRIL, 2017 to 31ST MARCH, 2018)

Sealed tenders in the prescribed proforma are invited for wholesale supply of Country Liquor 50[°] & IMFL 60[°] reputed distilleries/bottling plants (duly licensed by the Central or State Govt.) only those distillers & bottling plants, whose rates are approved by the Chandigarh Administration will be allowed to sell their products in U.T., Chandigarh for the wholesale supply of following types of liquor in Glass & PET bottles of 750ml, 375ml and 180ml packing size: -

- a) Country liquor of 50 degree proof
- b) Indian made foreign liquor i.e. Rum, Gin & Whisky of 60 degree proof

The basic quota of Country Liquor is fixed as 8,25,000 Proof Litres for the Excise Policy year, 2017-18 (from 07th April, 2017 to 31st March, 2018). The actual allotted quota of country liquor may vary from the above mentioned total basic quota, depending upon the extent of total allotment of licensing units (L-2/L-14A licences). The licencee holding L-2/L-14A licences has an option of changing (upto 100%) his allotted quota of country liquor into IMFL. There is also a provision of an additional quota upto 50% of the basic quota which can be demanded by the Retail Sale licenses (L-14A).

Rates should be quoted for supply of above products ex L-13 (inclusive of Excise Duty, VAT & Import Fee, etc. as applicable for the year 2017-18 commencing from 07th April, 2017 to 31st March, 2018) at Chandigarh, in the denomination of nine bulk litres in a separate sealed cover.

The prescribed proforma for submitting 'Financial Bid' can be obtained from the O/o of Asstt. Excise & Taxation Commissioner, U.T. Chandigarh on payment of Rs.10,000/- per form.

All the documents along-with the Earnest Money shall be sealed by the tenderer in the envelope marked "**Technical Bid**". The financial bid quoting the rates offered shall be sealed by the tenderer in a separate envelope marked "Financial Bid". Both these sealed envelopes will then be placed in a bigger sealed envelope marked "**TENDER FOR SUPPLY OF COUNTRY LIQUOR/IMFL**" and the same should reach the office of the Asstt. Excise &

Taxation Commissioner (U.T., Chandigarh situated at Additional Town Hall Building, Sector 17, Chandigarh) **by 02:00 P.M. on 06.04.2017.**

The 'Technical Bid' would be opened first on **06.04.2017 at 03:00 P.M.** in the office of the Assistant Excise &Taxation Commissioner, U.T., Chandigarh, in the presence of the tenderers who wish to attend the proceedings. Thereafter, scrutiny of these technical bids would be undertaken and the financial bids of only those tenderers will be opened, whose technical bids are found to be in order.
