The Inspectors shall identify the beneficiaries and ensure door step delivery of foodgrains. They shall also maintain the record on the mobile application. The Inspectors are also directed to maintain social distancing during distribution process and ensure compliance of all guidelines of GoI issued on COVID-19 pandemic. They are also directed to submit daily report of distribution of wheat and pulses to the DFSO. All Inspectors will submit their route plan with DFSO one day prior to the execution. On each vehicle, the Food & Supplies and Legal Metrology Inspector will be accompanied with one police constable provided by the Police Department, Chandigarh.
