Subject: - Payment of Dearness Allowance to Government employees of Jammu & Kashmir Government on revised rate effective from 01.07.2021.

The Government of Jammu & Kashmir, Finance Department (Codes Division), Civil Secretariat, Jammu/Srinagar has issued Government Order No.304-F of 2021 dated 17.11.2021 regarding payment of Dearness Allowance from the existing rate of 28% to 31% of the Basic Pay w.e.f. 1.7.2021 to its Government employees working in regular pay levels under 7th Pay Commission recommendations.

2. The Chandigarh Administration is pleased to adopt the abovesaid Government Order No.304-F of 2021 dated 17.11.2021 issued by the Govt. of Jammu & Kashmir, Finance Department (Codes Division), Civil Secretariat, Jammu/Srinagar w.e.f. 01.07.2021 in respect of the deputationists from the Govt. of Jammu & Kashmir working with Chandigarh Administration so as to regulate their DA rate of 31% of the Basic Pay w.e.f. 01.7.2021. The enhancement in DA rates from 31% to 34% w.e.f. 01.01.2022 and from 34% to 38% of the Basic Pay w.e.f. 01.07.2022 has already been granted to the deputationists vide Finance Department, Chandigarh Administration letter No.7000/4/1-F&PO(7)/2022/12944 dated 01.09.2022 and letter No.7000/4/1-F&PO(7)/2022/14719 dated 04.10.2022 respectively.

In continuation to the Government Order No 203 -F of 2021 Dated: 02-08-2021, it is hereby ordered that Government Employees working in regular pay levels under 7th Pay Commission recommendations, shall be paid Dearness Allowance as under:-

Existing Rate of DA per month	Revised Rate of DA per month	With Effect From
28% of Basic Pay	31% of Basic Pay	01.07.2021

- i. The term 'Basic Pay' in the revised pay structure means the pay drawn in the prescribed level in the Pay Matrix as per 7th Pay Commission recommendations, but does not include any other type of pay like special pay etc.
 - ii. The arrears on account of additional installment of Dearness Allowance with effect from July, 2021 shall be paid in cash in the month of November, 2021.
 - iii. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next

higher rupee and the fractions of less than 50 paisa may be ignored.


