CHAPTER 9

INDUSTRIES

Year-wise breakup of total registered factories, registered working factories and workers employed therein under section 2m(i), 2m(ii) and 85 of the factories Act, 1948. Under section 2m factory means any premises including precincts thereof:

- (i) Wherein ten or more workers are working or were working on any day of the preceding twelve months, and in any part of which manufacturing process is being carried on with the aid of power or is ordinarily so carried on.
- ii) Wherein twenty or more workers are working or were working on any day of the preceding twelve months, and in any part of which a manufacturing process is being carried on without the aid of power, or is so carried on and does not include a mine subject to the operations of the Indian Mines Act, 1923, or a railway running school.

Under Section 85, the Chandigarh Administration is empowered to notify any factory not covered under the above two sections.



Classification of Enterprises.

The Earlier concept of Industries has been changed "Enterprises" Enterprises have been classified broadly

- i) Enterprises engaged in the manufacture/production of goods pertaining to any industry; &
- ii) Enterprises engaged in providing/rendering of service.

"Manufacturing enterprises have been defined in terms of investment in plant and machinery (excluding land and buildings) and further classified into:

- Micro enterprises- Investment upto Rs. 25 lakh.
- Small enterprises- Investment above Rs.25 lakh & upto Rs. 5 crore.
- Medium enterprises- Investment above Rs.5 crore & upto Rs.10 Crore.

Service enterprises have been defined in terms of their investment in equipment (excluding land and buildings) and further classified into:-

- Micro Enterprises- Investment upto Rs. 10 lakh.
- Small enterprises- Investment above Rs.25 lakh & upto Rs. 2 crore.
- Medium Enterprises investment above Rs.2 crore & upto Rs. 5 Crore.
