ORDER UNDER SECTION 144 Cr.P.C.

Whereas, movement of VVIPs & foreign delegates is expected in U.T., Chandigarh for G-20 meet w.e.f. 27.03.2023 to 01.04.2023 and there is apprehension that some groups/organizations/unions may cause obstruction, annoyance or injury to the persons lawfully employed or other general public and endanger human life and property, disturb public peace and tranquility and cause riots and affrays.

And therefore I, Vinay Pratap Singh, I.A.S., District Magistrate, U.T., Chandigarh, am of the opinion that taking out procession, rally, protest, strike, making speeches, raising slogans by gathering/assembly of 5 or more people for aforesaid purposes etc. at & around Hotel – The Lalit, I.T. Park, Chandigarh, would cause obstruction, annoyance or injury to persons lawfully employed or other general public, disturb public peace and tranquility and cause riots and affrays and that immediate action is necessary for the prevention of the same.

Now therefore, I, Vinay Pratap Singh, I.A.S., District Magistrate, U.T., Chandigarh, in exercise of the power vested u/s 144 of Cr.P.C., do hereby order as a measure of emergency that the public in general or any member thereof is prohibited from taking out procession, rally, protest, strike, making speeches, raising slogans of gathering/assembly of 5 or more people for aforesaid purposes etc. at Hotel – The Lalit, I.T. Park, Chandigarh and within 100 meters from its periphery.

Provided that the above order shall not apply to:

- (I) The police or Para-military or military persons or any other Government servant on official duties;
- (II) The processions or meetings for which prior permission in writing of the District Magistrate/concerned Sub Divisional Magistrate, Chandigarh, has been obtained;
- (III) The customary and ritualistic procession in connection with weddings and funerals.

This order shall come into force from zero hours on 27.03.2023 and shall be effective up to zero hours on 02.04.2023.

In view of the emergent nature of the order, it is being issued ex-parte and is addressed to the public in general. Any breach of this order would invite action under section 188 of the Indian Penal Code.

This order shall be promulgated by affixing copy thereof at the Notice Boards of the office of the undersigned as well as the District Courts, Chandigarh and publication in the newspapers having circulation in the area, through the office of the D.P.R., Chandigarh.

ORDER UNDER SECTION 144 Cr.P.C.

Whereas, movement of VVIPs & foreign delegates is expected in U.T., Chandigarh for G-20 meet for the period from 27.03.2023 to 01.04.2023. In view of emerging threats due to recent trends of carrying out terrorist attacks by using Drones fitted with Improvised Explosive Devices by anti-national elements and keeping in view of the security of VVIPs and general public, it becomes imperative to declare the area of U.T., Chandigarh as "No Flying Zone" for the purpose of Drones and Unmanned Aerial Vehicles (U.A.V.s).

Now therefore, considering above, I, Vinay Pratap Singh, I.A.S., District Magistrate, U.T., Chandigarh, exercising the power conferred upon me under section 144 of the Cr.P.C., do hereby order that the whole of Union Territory, Chandigarh shall be "No Flying Zone" for the purpose of flying of Drones and Unmanned Aerial Vehicles (U.A.V.s) from 27.03.2023 to 01.04.2023.

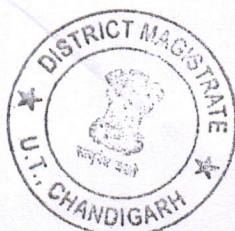
This order shall not be applicable on Law enforcement agencies including Police, Para-Military, Air Force, S.P.G. personnel.

This order shall remain in force w.e.f. zero hours on 27.03.2023 up-to zero hours on 02.04.2023.

In view of the emergent nature of this order, it is being issued ex-parte and is addressed to the public in general. Any breach of this order would invite action under section 188 of the I.P.C. and other relevant provisions of Law.

This order shall be promulgated by affixing copy thereof on the notice board of the office of the under-signed as well as the District Courts, Chandigarh and by publication in local newspapers through the office of the D.P.R., Chandigarh.
