I am directed to return herewith the following proposals which is directly received in this

Department for examination/consideration: Subject O.A No. 60/1199/2021 titled as Anita Luthra &ors Vs UT of Chandigarh &ors in S.No. 1. Hon'ble CAT, Chandigarh Bench, Chandigarh-reg. Conversion of 76 temporary posts of the Estate office, U.T., Chandigarh into 2. Creation of Posts in Department of Information Technology, Chandigarh 3. Administration Revival of one post of Assistant Food & Supplies Officer Revival of 01 post of Senior Assistant in respect of Sports Department, U.T. 4. 5. Chandigarh

- 2. In this regard, it has been observed for a long time that Chandigarh Administration are forwarding their proposals relating to creation/revival/conversion of posts/court cases directly to this Department without due examination by IFD and their Administrative Ministry, which is contrary of DoE's guidelines dated 12.04.2017 as far as creation of post is concerned and in the matter of court cases DoPT's O.M. dated 16<sup>th</sup> March, 2016, DoE's O.M. dated 16.05.2012 and Cabinet Secretariat's D.O. letter dated 25.02.1994 which state that all court cases filed in the Hon'ble CAT/Court have to be defended by the Administrative Ministry/Department/Organization where the Government servant is serving or has last served and in case other Ministries/Departments have been arrayed as respondents, they are to be treated merely as proforma parties and the matter has to be dealt with by the Administrative Ministry itself on behalf of all the other Ministries/Departments involved.
- 3. In this regard a meeting was held with AS & FA of MHA. He informed that with regard to financial proposals including creation / upgradation of posts etc. of UTs which which sent to MHA by UT Administration are re-forwarded by MHA to subject matter Ministry for taking necessary action which only results in delay in processing in proposals. Thus, vide their OM dated 24.10.2017 and dated 16.08.2022 MHA has advised all UT Administrations to forward their proposals to concerned subject matter Ministry under endorsement to UT Administration of MHA. The proposals would be examined by

subject matter Ministry and they shallseek necessary approval of DoE. Therefore, all UTs are to process their proposal through subject matter Ministry as per MHA's O.M dated 24.10.2017 and 16.08.2022.

- 4.. Therefore, Chandigarh Administration is requested to kindly ensure that that all such proposals may be routed through their subject matter Ministry as per MHA's directions contained in O.M dated 24.10.2017 and 16.08.2022 and forwarded to this Department in terms of this Department instructions dated 12.04.2017 with the approval of competent Authority. No proposal received directly shall be considered in this Department.
- 5. This issues with the approval of competent authority.
