 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Union Public Service Commission (Exemption from Consultation) Regulations, 1958, in Schedule II, for item 6 and the entries relating thereto, the following shall be substituted, namely:-
 - "6. All Group 'A' and Group 'B' posts in pay level up to level 13A in the Pay Matrix filled by the method of deputation or deputation (including short term contract)".
