Discontinuation of Allowances on Punjab pattern admissible to the employees of Chandigarh Administration with effect from 1.4.2022 in pursuance of the GOI, MHA notification dated 29.3.2022

I am directed to refer on the subject cited above and to state that with issuance of the notification of Govt. of India, Ministry of Home Affairs bearing No.G.S.R. 230 (E) dated 29.3.2022, the allowances i.e. House Rent Allowance, City Compensatory Allowance, Conveyance Allowance, Mobile Allowance, Fixed Medical Allowance etc and other such specific allowances admissible to the specific categories of the employees admissible on Punjab pattern to the employees of Chandigarh Administration were continued w.e.f. 1.4.2022 as matter regarding implementation of the pay scales on Central Pattern w.e.f. 1.4.2022 was under consideration and on the issuance of this Administration's notifications dated 29.3.2023 and 14.6.2023 titled the Union Territory of Chandigarh Employees (Revised Pay) Rules, 2023' and Electricity Wing of Engineering Department UT Chandigarh Employees (Revised Pay) Rules, 2023' respectively, the Administration has also adopted various O.M.s of Govt. of India regulating House Rent Allowance, Children Education Allowance and Transport Allowance admissible to the Central Govt. employees under 7th CPC in respect of the employees of UT, Chandigarh Administration on and from 1.4.2022.

- 2. Now, it has been decided to discontinue all the allowances on Punjab pattern (except Fixed Medical Allowance) admissible and drawn by the employees of UT, Chandigarh Administration on Punjab pattern with effect from 1.4.2022. However, medical reimbursement facility for UT employees /pensioners/family pensioners and Fixed Medical Allowance presently being paid to the employees of UT Chandigarh Administration on Punjab pattern shall stand continued to be paid till the decision is received from the Govt. of India regarding Central Govt. Health Scheme (CGHS).
