No.C-15238-FII(9)-2022/19296 In accordance with the provision under Rule 15 of Solid Waste Management Rules, 2016, notified by Government of India, Ministry of Environment, Forest and Climate Change, New Delhi, the Administrator, Union Territory, Chandigarh is pleased to notify following amendments in the Municipal Corporation, Chandigarh Solid Waste Management Bye-Laws, 2018:-

## 1. Short title and commencement. -

- (i) These Bye- laws may be called Municipal Corporation, Chandigarh 'Solid Waste Management Bye-Laws, Amendment, 2022.
- (ii) These shall come into force from the date of its publication in the Official Gazette.

### 2. Amendments are as under:-

(i) The User Fee from each Premise/ House/ Dwelling Unit/ Flat as prescribed in Schedule-I of Solid Waste Management Bye- Laws 2018, shall be amended and substituted as under:-

Late Payment Surcharge (LPSC) shall be charged at the rate of 10% of the user fee/charges if the user fee/charges are not paid within 30 days of raising the demand.
