Subject: Regarding one time option to the Government pensioners who have retired between 1.1.2016 to 30.6.2021 to deposit the revised commuted value of pension in the Government treasury.

Sir/ Madam,

In continuation to the instructions No. 3/4/2023-3FPPC/151 dated 05.06.2023 on the subject cited above

2. I am directed to invite a reference on the subject cited above and to say that the Government had taken a conscious decision to grant one time option to the Punjab government pensioners, who have retired between 01.01.2016 to 30.06.2021, to deposit the revised commuted value of pension in the Government treasury vide letter mentioned above. This option was available till 31.7.2023.

2. Now, after considering the grievances of the pensioners, the government has decided to extend the date of one time option to 31.03.2024 for depositing the revised commuted value of pension in the Government treasury for the government pensioners who have retired between 1.1.2016 to 30.6.2021.

3. This option can also be exercised by those pensioners, who have retired between 1.1.2016 to 30.6.2021 and whose pension is revised by the Accountant General, Punjab after the issuance of above cited instructions dated 05.06.2023.

Conditions prescribed in the instructions No. 3/4/2023-3FPPC/151 dated 05.06.2023 shall remain applicable.
