Health Scheme (CGHS) facilities to the pensioners of Union Territory of Chandigarh, who have superannuated on or after 01.04.2022.

In pursuance of Govt. of India, Ministry of Home Affairs notification dated 29th March, 2022 circulated by the Chandigarh Administration, Department of Personnel vide letter No. 28/17/94-IH(7)-2022/5169 dated 30th March, 2022, the Chandigarh Administration is pleased to adopt the aforesaid Office Memorandum dated 13th November, 2023 and 02nd February, 2024 issued by the Govt. of India, Ministry of Health & Family Welfare, New Delhi and extend the benefits of Central Govt. Health Scheme (CGHS) to the pensioners/ family pensioners of Union Territory of Chandigarh Administration who have retired/ will retire on or after 01.04.2022 and their dependents (As defined in CGHS Scheme) as approved and conveyed by the Govt. of India, Ministry of Health & Family Welfare, New Delhi, on the same terms and conditions mentioned therein. The CGHS benefits will also be admissible to the pensioners/family pensioners retiring on or after 01.04.2022 and who are covered under New Pension Scheme (NPS) as per guidelines issued by the Ministry of Health & Family Welfare OM No. S.11011/10/2012-CGHS(P)/EHS, dated 28.03.2017 (copy enclosed).
- 3. A Standard Operating Procedure (SOP) drafted in consultation with CGHS local office is also enclosed as Annexure-A for information and necessary action. Accordingly, it will be responsibility of the concerned Head of Department and Drawing & Disbursing Officers to officially circulate the above decision and Standard Operating Procedure (SOP) to all such eligible beneficiaries of their respective department. Eligible pensioners/family pensioners shall get themselves enrolled for CGHS Scheme by 31.10.2024 positively. The employees who will retire in future shall be required to enroll themselves provisionally for CGHS within three months from the date of superannuation on the production of copy of Retirement Order OR three months from the date of issuance of Pension Payment Order by the Pension Sanctioning Authority.



The CGHS facilities to the eligible pensioners/family pensioners and their dependents will be regulated as per Central Govt. Health Scheme and the instructions/guidelines issued by the Government of India/ Ministry of Health & Family Welfare from time to time.

Guidelines on CGHS Benefits to Central Government Employees (Serving/Retired) covered under New Pension Scheme

The undersigned is directed to say that the matter regarding extension of CGHS facilities to Central Government employees (serving/retired) covered under New Pension Scheme (NPS) was under examination in this Ministry.

2. The matter has been examined in this Ministry in consultation with Department of Expenditure and Department of Pension and Pensioner's Welfare and the guidelines for NPS subscribers to be eligible for CGHS facilities are as follows:—

(a) Minimum years of qualifying service for eligibility of CGHS membership after retirement—10 years.

(b) No minimum qualifying years of service for availing CGHS facilities in case of death/disability.

(c) In case of absorption into AB/SBs, NPS subscribers can avail CGHS after their retirement only if the SB/AB where they were absorbed is covered for their retired employees, subject to condition (a) above.

(d) In case of deputation to AB/SBs, no CGHS coverage till such period of deputation continues unless the entity to where the employee has been transferred is covered by CGHS.

(e) Status quo to be maintained for serving NPS subscribers subject to conditions at (c) and (d) above.

(f) Other conditions such as definition of family, CGHS contributions, conditions of dependency, etc., will be applicable as per existing rules.

3. This issues with the approval of the Competent Authority.

- (iii). Residence Proof: Photocopy of latest bill of Electricity/Water/ Telephone/Mobile/Voter Card/Passport/Ration Card.
- (iv). Photocopy of Aadhaar Card of each members.
- (v). If Fixed Medical Allowance is drawn, it is to be stopped and a certificate of stoppage of Fixed Medical allowance is to be obtained and submitted along with the application.
- (vi) Contribution of CGHS online in BHARATKOSH Portal, (17)-Ministry of Health and Family Welfare, Purpose: Pensioners Contribution for CGHS Card- Chandigarh, Dehradun, Pay & Accounts Office (PAO): 021186, PAONICD- Drawing & Disbursing Office (DDO) 208148, (Joint Director CGHS CHD)- (Print out-Receipt and Challan).
- (vii) Surender Certificate of in service CGHS Card from office.
- (viii) Photocopy of proof of Date of Birth of all members.
- (ix). Undertaking by the Pensioner as per the attached format.
- (x). In case, wife is pensioner or serving in Govt./State Govt. of India, a certificate from the respective Department/Bank regarding Stoppage of Fixed Medical Allowance/Indoor facilities should be attached.
- (xi). In case of Dependency:-
- (i) Name & Date of Birth of dependent (Photocopy of age proof should enclosed).
- He/She is unmarried, un-employed, fully dependent, residing with pensioner and their monthly income from all source is not exceeding Rs. 9,000/-.
- (iii) In case of divorcee/legally separated daughter, certified copy of legal documents may be submitted
- (iv) In case of Son: Son up to the age of 25 years is eligible for medical facility under CGHS.
- (v) In case of Daughter: Daughter is eligible for medical facility under CGHS irrespective of age subject to start earning or get married whichever is earlier.
