No. In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, Notification S.O. No. 3267, dated 1st November, 1966, the Administrator, Union Territory, Chandigarh makes the following Rules, regulating the method of recruitment to Group 'A' post- Deputy Controller (Local Audit) in the Local Audit Department, Union Territory, Chandigarh namely:-

1. (i) Short title and commencement.-

These rules may be called the Chandigarh Local Audit Department Service {Group-'A' Post-Deputy Controller (Local Audit)} Recruitment Rules, 2024.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. Application:-

These rules shall apply to the posts specified in column 1 of the Schedule annexed to these Rules.

3. Number of posts, classification and scale of pay.-

The number of posts, their classification and the scales of pay attached thereto, shall be as specified in columns 2 to 4 of the said schedule.

4. Method of recruitment, age limit and other qualifications etc:-

The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in columns 5 to 13 of the said Schedule.

5. Disqualification.- No person:-

(a) Who has entered into or contracted a marriage with a person having a spouse living

OR

(b) Who, having a spouse living, has entered into or contracted a marriage, with any person, shall be eligible for the appointment to the said posts.

Provided that the Administrator, Union Territory of Chandigarh may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and there are other grounds for so doing exempt any person from the operation of this rule

6. Power to Relax:-

Where the Administrator, Union Territory, Chandigarh is of the opinion that it is necessary or expedient so to do, he may by order, for reasons to be recorded in writing relax any of the provisions of these rules after consultation with the Union Public Service Commission, New Delhi in respect of any class or category of persons.

7. Savings:-

Nothing in these rules shall effect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Caste, Scheduled Tribes, Other Backward Classes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by Chandigarh Administration from time to time in this regard.

8. Repeal:-

Chandigarh Local Audit Department Service (Group-A Post-Deputy Controller (Local Audit)) Recruitment Rules, 2016 notified on 23rd May, 2016 are hereby repealed.
