**PUBLIC NOTICE**

**Updation of State Register (Part A) of Council of Homoeopathic System of Medicine, U.T. Chandigarh**

Attention of all Homoeopathic Practitioners is invited to provisions of (i) National Commission for Homoeopathy Act, 2020 & Rules and Regulations framed there under and (ii) Punjab Homoeopathic Practitioners Act, 1965 as extended to Union Territory of Chandigarh.

As per Section 33 (1) of National Commission for Homoeopathy Act, 2020, any person who has a recognised medical qualification in Homoeopathy under this Act and qualifies the National Exit Test held under section 15 shall have a licence to practice Homoeopathy and shall have his name and qualifications enrolled in the National Register or a State Register, as the case may be:

As per Section 32(5) of the Act, every State Medical Council shall maintain and regularly update the State Register in the specified electronic format and supply a physical copy of the same to the Board of Ethics and Registration for Homoeopathy within three months of the commencement of this Act.

**Regulation 3(3) reads as under:-**

Every State Medical Council for Homoeopathy shall also maintain and regularly update the State Register in the Form-1 and Form-2, both in the electronic and physical formats and also supply physically signed two copies of the same to the President of the Board of Ethics and Registration for Homoeopathy on quarterly basis as per the time schedule mentioned in the following table, namely:-

Sr. No.	Details of Data	Time-Period

1.	Data of Registered Practitioner From 01 <sup>st</sup> January to 31 <sup>st</sup> March	upto the 15 <sup>th</sup> April
2.	Data of Registered Practitioner From 01 <sup>st</sup> April to 30 <sup>th</sup> June	upto the 15 <sup>th</sup> July
3.	Data of Registered Practitioner From 01 <sup>st</sup> July to 30 <sup>th</sup> September	upto the 15 <sup>th</sup> October
4.	Data of Registered Practitioner From 01 <sup>st</sup> October to 31 <sup>st</sup> December	upto the 15 <sup>th</sup> January

**Regulation 9** of "National Commission for Homoeopathy (Manner of Preparation and Maintenance of National Register for Practitioner of Homoeopathy) Regulations, 2022" reads as under:-

**9. Updating the details of License in State or National Register. –**

(1) The license of a medical practitioner of Homoeopathy shall be updated after every five years in a uniform pattern by all the State Medical Councils for Homoeopathy and by National Commission for Homoeopathy for the direct registrations.


(2) Any practitioner who fails to get his license updated within six months from the due date, shall forfeit his right to practice in Homoeopathy and also forfeit the right to continue in employment based upon his license, unless updated with the payment of fees as may be laid down by State Medical Councils for Homoeopathy or with the payment of fees as specified in Schedule along with the application in Form-9 in case of direct registration by the National Commission for Homoeopathy, as the case may be:

Further, All the Homoeopathic practitioners registered in other states/UTs but, practicing in the UT., Chandigarh are required to enrol in terms of procedure mentioned in **Regulation 8 "Practice or Employment in other State"**.

**Directions**

In view of the above, following directions are hereby conveyed through this Public Notice:-

- (i) All Homoeopathic Practitioners registered in Part A of the State Register maintained by Council of Homoeopathy System of Medicine, U.T. Chandigarh **shall register themselves in prescribed format of National Commission of Homoeopathy** as available on the Portal "[ayushedu.bisag-n.gov.in](http://ayushedu.bisag-n.gov.in)" immediately.
  - (ii) **Updation after every five years:-** All the Homoeopathic Practitioners registered in the Part-A of the register maintained by Council of Homoeopathic System of Medicine U.T., Chandigarh shall get the details of their license updated after every five years on the portal "[ayushedu.bisag-n.gov.in](http://ayushedu.bisag-n.gov.in)".
  - (iii) All the Homoeopathic practitioners registered in other states/UTs but, practicing in the UT., Chandigarh are requested to **enrol themselves in CHSM U.T, Chandigarh on the above portal.**
- 4 Failure to follow the provisions of the Act/ Rules/ Regulations will invite action as per requisite provisions.
